STSA-C was added back two points for the team lost to the defaulting team.

However, as I visited the Tiger Bowls official website recently, it appeared that Mr. Stanley Lai has represented Zhongshan, China for the Tiger Bowls World Invitation 2011 (China Tour) and was crowned the 3rd runner-up. Mr. Lai has been representing Zhong Gang, China for the China Open 2012 as well.

Enclosed please find some action photos during the Tiger Bowls World Invitation 2011 for your reference.

Both Tiger Bowls World Invitation and China Open were world bowls sanctioned event. The act of Mr. Lai was violating the World Bowls Regulations - clause 9.11 if Mr. Lai represents HK for the world singles champ of champ. To be fair for all participants for the National Singles 2011, the 1st runner up players should replace Mr. Lai's position for this world singles champ of champ event.

Finally, Mr. Lai also attained a position in the HK squad for the year 2012-13, which means he could be chosen to represent Hong Kong in an international competitions within this year. With the background of Mr. Lai representing China before for the above event, that is not fair for the HK squad players and the players who just missed out the squad.
