League panel ruling

Deduct two points from ILBC-B for a bowler playing M2584 and 2566 in same fixture day. Add two points to KCC-C for their lost to defaulting team.

Deduct one point from HKFC-B on late response in M2623 rearrangement.

Deduct one point from VLBC-A on late offer in M2632 rearrangement.

Deduct two points from CCC-E for a tied bowler playing down in M2662. Add two points to AYFP-B for their lost to defaulting team.

Deduct four points from HKSAP-A for failure to arrive in M2674.

Deduct two points from SBSC-B for a bowler playing M2741 and M2752 in same fixture day. Add one point to CCC-D for they tied with defaulting team.

Deduct two points from ILBC-C for a bowler playing M2761 and M2782 in same fixture day. Add two points to KBGC-E for their lost to defaulting team.

Deduct two points from ILBC-B for a bowler wearing improper footwear in W2846.

Case Report

- 1. Mixed Triples #223. Complaint received from IRC regarding a player's attitude during match. Matter under investigation by Discipline Panel.
- 2. Women's Novice Pairs match #125. Email received from HKYDT regarding a probable misuse of the laws by HKCC team. Two errors in the HKCC team's part were found, namely regarding Paragraph 10.2 and 10.3 of Section 1.2 of the Laws of the Sport of Bowls (improper delivery of the jack) and LBA Bye-law 1.7 (bowls). Panel suggested that host clubs should make available a set of WB laws and LBA bye-laws as a ready reference for players. Panel decided to defer the decision to take any appropriate follow-up action against the HKCC skip to HKCC regarding any attitudinal issue prima facie in the HKYDT submission. Panel would like to remind all players participating in national competitions should act and present themselves in a level of manner expected of a member of good standing of their representing club.
- 3. Men's 2-4-2 Pairs Final was originally scheduled for the Finals Day. Due to conflict of schedules of Neil Herrington (HKFC), one of the finalists who is also qualified for the Semi-final of the Nong's National Singles to be held in the morning of the Finals Day and, if winning, the Final in the afternoon, the Men's 2-4-2 Pairs Final has been advanced by one week to 10.00 a.m. on Sunday, 6th December at KBGC, thanks to the FC team, the other finalist for agreeing to the change and to KBGC for providing the rink.
