Report at the meeting

Walter Kwok VP (International) Dear HKLBA Council Members,

## **Re: Complaint Handling Process Revisit**

Recently SBI launched a complaint against GLBC, regarding the drawing procedure during women's premier league game W2154 GLBC-A vs SBI-A on 22 Aug 2021. GLBC-A captain was accused of not exchanging the score cards before assigning rink numbers.

Though the league panel has decided no action should be taken due to lack of evidence, GLBC general committee has conducted an internal investigation on the incidence. By examining the score cards of opponent team in the previous few league games, it is found that our captain always marked the rink numbers in the same specific position of these score cards, and of course it coincides with that on the SBI score cards. Therefore, we are confident that our captain did exchange the score cards with SBI's captain before writing the rink numbers on the cards.

This triggers our concern on the current complaint handling process, and would raise the below for the council's discussion:

- 1. Any dispute about card drawing procedures should be raised before the commencement of the league game, and any corresponding complaint after the match should not be entertained.
- 2. Any complaint raised up should be qualified. It should not be presented to the panel for discussion if it is not substantiated with supporting evidence, in order to eliminate the time wasting of panel members.
- 3. Penalty scheme to the complaint side should be established for complaint found to be a "false accusation" at the end.
