1. CONFIRMATION OF PREVIOUS MINUTES

The minutes of the previous meeting were confirmed.

2. MATTERS ARISING

2.1 Bye-laws amendment version 15 was sent out to Clubs for comments on 9 March. It would be deemed passed and effective after 14th day (i.e. 23 March) if no affecting comments received. Councillors have no objection to the arrangement.

3. CORRESPONDENCE

The Hon. Secretary read out the main correspondence received since the last meeting.

- 3.1 31.1.2011 received an invitation from US Lawn Bowls Association inviting HK to send two men players to the MAP International Bowls Challenge in Oct. 2011 in South California.
- 3.2 1.2.2011 received an invitation from Bowls Japan inviting HK to send a mixed triples' team to 2nd Japan International Open in Oct. 2011.

4. TREASURER'S REPORT

4.1 Outstanding receivables as at 21 March 2011 was presented. Clubs were reminded to settle as soon as possible amounts that were outstanding, especially those over 90 days.

5. NATIONAL LEAGUE

- 5.1 The dispute from CLP on the penalty of a registered player playing down was rejected. League panel ruling sustained.
- 5.2 Triples League 2010 completed. Website result was final.
- 5.3 Premier League Fixture v1 was approved. Clubs using public green can start their green booking.
- 5.4 All rescheduled games have to be fixed before 14 May. Home sides had to make their offers before 1 May.
- 5.5 VP League explained the current practice on promotion and relegation recommendations of each division. Any suggestions on improvement or changes can be put forward to Council for approval.
- 5.6 HKFC convenor advised that HKFC outdoor green might be closed in the first half for maintenance. HKFC will inform HKLBA office immediately once a decision was made. The Councillors agreed that if the green was closed, all games in HKFC outdoor would switch to HKFC indoor and be rescheduled.

7. **DEVELOPMENT**

7.1 Youth Novice Competition Youth Novice Competition was successfully held. A total of 41 participants took part in the event (27 boys & 14 girls).

8. TECHNICAL

8.1 Umpire training course would be organized in April. 21 applications were received.

9. INTERNATIONAL COMPETITIONS

- 9.1 HK Squad list 2011-12 was tabled for and sanctioned by the Councillors.
 - VP explained that the attendance of squad at training camp was important as it reflected the level of commitment, and this piece of information would be passed on to Selectors for their reference.
- 9.2 World Champion of Champions 2011 (4-13 Nov. 2011, HK)
 - Winners of National Singles Li Ming Sum & Grace Chu would take part in the event.
- 9.3 World Cup & World Junior Cup 2011 (12-20 April 2011, Australia)
 - Estimated budget was tabled for information.
- 9.4 Tiger Bowls World Invitation-HK & China Tours (12-17 March 2011, HK & Shenzhen, China)
 - YDT girls team was the winner of Plate event at HK Tour, while HK team entered into quarter-final at China Tour.
- 9.5 HKFC International Mixed Fours Tournament (2-3 April 2011, HK)
 - LBA and YDT team were invited to take part in the event.

10. HKLBA Golden Jubilee Year 2011

- 10.1 China Inter-port Competition 2011 (22-23 May 2011, HK)
 - 8 teams from China and Macau have confirmed to participate in the event. Also invited were all our 2011 Premier League Div One Clubs and Clubs established for over 50 years making a total of 24 teams.
 - USRC (headquarters) and KCC would be the playing venues for the event.
- 10.2 World Champion of Champions 2011
 - The Venue Clubs included KBGC (headquarters), KCC, CdeR, USRC and FC being the reserve venue.
- 10.3 HKLBA Golden Jubilee International Bowls Mixed Pairs Classic 2011
 - The Venue Clubs would be the CCC (headquarters), HKFC and IRC.
 - All affiliated Club could enter a Mixed Pairs team. It was expected to have 64 teams.
- 10.4 Golden Jubilee magazine
 - In progress.

- 11.1 VP-Technical reported that the HKLBA website would be ready on 1 April 2011.
- 11.2 Convenor of LBTC thanked HKLBA and Venue Clubs for their support to Tiger Bowls.
