1. CONFIRMATION OF PREVIOUS MINUTES

The minutes of the council meeting held on 22 September 2014, having been circulated to all members of the Council of Management were taken as read, confirmed, and approved.

2. MATTERS ARISING

None.

3. CORRESPONDENCE

The Hon. Secretary reported the main correspondence received: -

- 3.1 World Bowls invited HK to participate in the 2015 World Junior Championships and 2015 World Cup to be held in Australia in March and April respectively.
- 3.2 LBTC asked HKLBA to assist them by obtaining sanction from World Bowls for the Tiger Bowls World Invitation "Hong Kong Tour" 2015. LBTC also invited HKLBA to participate at the event and the Tiger Bowls "China Tour" 2015 in March 2015.

4. TREASURER'S REPORT

- 4.1 Outstanding receivables as at 3 November 2014 were presented. Members were reminded to settle the outstanding amounts as soon as possible.
- 4.2 Hon. Treasurer repeated his report on the Association's financial status at the AGM as some Councilors were absent last time. Whilst the financial status were stable there might be a cash flow difficulty in the future in consideration of the following:
 - Staffing costs and programme costs were not fully covered by LCSD subvention and the expenses to be incurred at future major international events, e.g. Asia Pacific Championships and World Championships may create a burden to HKLBA:
 - HKSI do not provide subvention for the cost of the additional staff already employed to administer their programmes;
 - The only source of income is from entry fees of League Games and National Championships;
 - To improve the financial situation of the Association, proposals for increases in entry fee of both events were considered necessary.
- 4.3 Payment for services provided by Councilors
 - Hon. Treasurer referred to the discussions at the AGM and the recent proposal to consider changes to the M&A to enable Councilors to be paid for services provided. He explained the reasons why Officers should not be paid and why he did not want to change the M&A. To allow payments to club representatives only, changes to bye-law clause 1.31 regarding the Voting Rights will be proposed accordingly.

5. NATIONAL LEAGUE

- 5.1 The League Panel rulings on Premier League 2014 were sanctioned. The results as announced on the HKLBA website were official and final.
- 5.2 For Triples League 2014, most re-arranged games were fixed. Four sides were penalized for failing to response timely in rearrangements.
- 5.3 VP League would circulate a proposal of two options to increase LBA income. Decision would be made in next CoM meeting.

6 NATIONAL COMPETITIONS

- 6.1 A report was tabled before the meeting.
- 6.2 The proposals to change entries fee were tabled and approved by the Councillors.

8. TECHNICAL

8.1 2 sessions of First Aids course were conducted in October, 2014. A total of 45 coaches attended.
