7. DEVELOPMENT

7.1 Under 25 Singles Championship completed successfully on 25 Oct. 2015. A total of 44 players took part in the event.

8. TECHNICAL

- 8.1 HKLBA would advise LCSD the proper ways to maintain the Tai Po green better.
- 8.2 Victoria Park had started construction of the 2nd bowling green in early October and was expected to open in January 2016.
- 8.3 Refurbishment of Ap Lei Chau indoor green commenced in November 2015 and was expected to re-open in April 2016.
- 8.4 It was hoped that LCSD would give us good news in a couple of months regarding a new bowling green on Kowloon side.
- 8.5 A new indoor green was planned in Tai Po, which is opposite to the Tai Po Centre, is yet to be approved.
