1. ACCEPTANCE OF PREVIOUS MINUTES

The minutes of the council meeting held on 23rd October, 2017, having been circulated to all members of the Council of Management, were taken as read, confirmed, and approved.

2. ACCEPTANCE OF THE AGENDA

AWASG raised their intention to discuss the arrangement for the lawn bowls cabinet at Victoria Park as an AOB item. Other than that, the Agenda of the Meeting was accepted by all councilors.

(Post meeting note: This agenda item would be withdrawn for the time being lest members would be confused with AOB item.)

3. MATTERS ARISING

4. CORRESPONDENCE

- 4.1 HKLBA received an invitation from Chinese Multi Bowling Association to participate in the 2017 China National Lawn Bowls Classic and "HuaShen" Carnival at Jiaxing, Zhejiang Province from 28th to 30th November, 2017. HKLBA would invite Hong Kong Team to participate.
- 4.2 HKLBA received a letter from the SF & OC with corresponding policy of the HKSAR Government, highlighting the statement issued by WHO (World Health Organization) against any commercial sponsorship by Tobacco Company Funded Foundation. It had been circulated to all convenors in November with a reminder that all clubs should comply with the policy of the HKSARG pertaining to the WHO Statement.

5. TREASURER'S REPORT

Summary of outstanding receivables as at 4 December 2017 was tabled. The Treasurer reminded all members to settle the outstanding amounts as soon as possible, and latest by the Chinese New Year, 2018.

6. NATIONAL LEAGUE

- 6.1 For the League Panel rulings, 1 points was deducted from CSD-B for the late offer of 49092 in Triples League 2017.
- 6.2 The Men's and Women's final results of Premium League 2017 had been issued on website and listed as follows:

- 6.3 The League Panel proposed an additional Bye-Law 3.7.c and 4.7.c in relation to the addition clause on Tied player as follow:
 - 3.7.c & 4.7.c If a player is coming to tie to a side and the club has more than one side in the same division, the player will tie to the side with most games played in that division. If the number of games played in that division is equal, the player will be tied to the side with last game played in that division.

There being no further comment from councilors, the above recommendations would be taken effect immediately.

- 6.4 The League Panel proposed to clarify the following Bye-Law in relation to the ranking system of champion team
 - 3.10.c. The skip acquiring the highest number of points, if equal by shot difference, in each division in a season will be awarded the title of Champion Team along with the three players with whom he has played the highest number of matches in that season.
 - 3.10.d. If points and shot difference are equal, both teams will be awarded the title of Champion Team.

Similar changes apply to Triples League on 4.10.c and 4.10.d.

- 6.5 HKJC had proposed eleven sides per division in Triples League. The proposal was circulated to all convenors for comment and decision would be made in next meeting.
- 6.6 TMSA had received a notice from LCSD that the green would be closed at least for three weeks beginning from 15 January 2018. Since they would have at least ten games to be played during that period, they had nominated Tai Po Waterfront Park Outdoor Bowling Greens to be their temporary neutral green. TMSA had duly informed all other opponent clubs, which could also negotiate with them if re-scheduling or re-selecting another neutral green would be required.

7. NATIONAL COMPETITIONS

- 7.1 Women Knock-out Singles was scheduled for 10 December, 2017 and the Final would be held at CdeR. Men Knock-out Singles was scheduled for 17 December, 2017 and the Final would be held at KCC.
- 7.2 HKLBA was still looking for venue for the Champion of Champions Championships 2017.

- 13.4 The Presentation Dinner would be held at Tsim Sha Tsui East on 25th May, 2018.
- 13.5 A bid for World Bowls Championships 2024 had been submitted to World Bowls last week. HKLBA would wait for the result in the World Bowls meeting held in April 2018. The President took note that hitherto there had not been other bidder for the event.
- 13.6 AWASG raised their concern on lack of lawn bowls cabinet at Victoria Park (V.P.). As a new member of the Council, AWASG was allocated a cabinet by HKLBA in July by means of a transfer from an existing bowling club. However, the existing club had not released their cabinet to AWASG yet while the Triple League would commence shortly. They opined that some kind of principle or rule should be developed to govern storage allocation in public greens, as the sports was becoming more popular nowadays. Besides, they also urged HKLBA to resolve their imminent problem with that existing club and to establish dialogue with LCSD to improve the situation. AWASG also considered that it would be a discipline issue if that existing club did not comply with HKLBA's instruction in releasing their cabinet. VP (Technical) undertook to further talked with the existing club so involved within the week and discuss with LCSD for enhancement.
