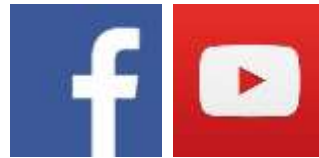

Notes for Player

The duty umpire will announce the commencement of trial ends 10 minutes before the appointed match start time. Any player arriving after the announcement shall lose the right to play trial ends.

Any team or singles player not reporting in person to the duty umpire before the appointed match start time shall forfeit the match.

No outside food or drinks allowed. Smoking is prohibited outside designated Smoking Areas.

No spectator allowed.

Players must wear a face mask at any time within the USRC except when playing, eating or drinking.

Players entering the Club will have their body temperature checked to ensure that they are healthy. Player with fever or has symptoms associated with Covid-19 infection (ie. fever [37.5 C or above] malaise, dry cough, shortness of breath, headache or other flu-like symptoms) will be denied entry to the venue.

Any person who has been in close contact with someone who arrived in Hong Kong from the Covid-19 affected countries and regions or is undergoing 14-day quarantine is not allowed to enter the venue.

In case of any deficiency, the Organizers reserve the right to amend them at any time without further notice.
