National Championships Panel Report on 7th March 2016

Case report

- Men's National Pairs #213 KCC Team requested the Panel to re-consider the walk-over claim of their opponents. After examining the details submitted, the Panel decided to uphold the walkover claim of the HKYDT team.
- 2. Men's National Pairs #320 IRC Team disqualified in accordance with Bye-law 6.7.c & e, in that the substitute in the IRC team played as Skip which is not allowed by the bye-law. In the application of 6.7.e, the Panel does not allow a substitute to be skip in his second match with the team. The substitute is only allowed to act as skip in his third match with the team. CPLBC team declared the winners of the match.
- 3. Two women's and one men's players were disqualified from Round 1 of Champion of Champions due to late arrival.
- 4. CLP team is seeking to replace three players originally entered for the Aitkenhead Fours after the draw. The case is in progress.

Men's National Pairs 2015

Due to potential clash of two players schedule with the Champ of Champs fixtures on Sunday, 6th March, and one of the potential home greens of QF3 in FC would be used as a Champ of Champs Round 2 venue at the same time, the Semi-finals have been re-scheduled to 10am, Sunday 3rd April. The restriction on re-scheduling of Quarter-final matches by mutual agreement has been lifted.

Duplicate Players Name

An enquiry was received from a member of USRC about his player name appearing with middle initials in the fixtures without his agreement. As a background, the Panel instructed the office to examine the national competitions player records last year with a view to eliminate duplicate player names to avoid ambiguity. Names used by more than one player were added with middle initials chosen randomly for distinction purpose. The distinction is considered necessary for identification purpose because a player may represent different clubs in different national competitions. Case in progress.
