Case report

- Men's National Fours #303 CCC team alleged being misled by FC team into agreeing not to play at the declared home venue of FC team. CCC team stopped play after 12th end. The Panel examined the submissions from both teams and ruled that FC Team would be declared the winner of the match.
- 2. Aitkenhead Fours Requests from CLP men's team and USRC women's team to use more than one substitute were rejected based on Bye-law 6.7.b and CoP.
- 3. Mixed Fours #304 CCC team used a substitute without prior notification to the Panel as required by Bye-law 6.7.b and repeated in the fixtures. Case in progress.

At the council meeting on April 25, 2016 the councilors have endorsed the following game arrangement during extreme weather condition which was not covered under the current byelaws:

- 1. Postpone of games should only be considered when the temperature reached 35C or below 8C at the scheduled starting time. The temperature should be referenced to the Regional Weather report issued by the Hong Kong Observatory.
- 2. If both sides mutually agree, the game can be postponed even if the weather did not fall into this requirement.
- 3. All postpone arrangements will follow the byelaws of the League and National Championships
- 4. The cost for public greens will be borne by the side who raised the postponement request.

The arrangement will be effect immediately.
