Notes from VP National League

2017 Premier League

Due to the withdrawal of AYFP-B women, there will be 9 sides in Division 5.

After the fixture was finalized, CdeR withdrew their women C side making 8 sides in Division 5. The league panel suggested following rulings:

- No change on fixture, any opponent played against CdeR-C will get a bye. There is only 8 sides in women Division 5, in such case each week may have two sides being bye.
- If public greens have booked and paid the green fees, CdeR should bear the cost of green fee damages.
- Give warning to CdeR and NOT allow them to enter women C side in coming next premier league season as per bye-law 3.8.g.

Other league panel rulings:

- Deduct one point from women CCC-B because of no offers being made.
- Deduct one point from men IRC-D due to not responding to home side offers timely.

HKSAP applied to change home venue from SLY to YCK

We did not receive any comment or rejection about the application. The change will take effect from Triples League 2017.

National Competition Case Report

Novice Singles

- In Men's Novice Singles 2017 Ref 408, both sides sought for Panel's decision due to miscommunication. After studying the case, Panel instructed the match should play as scheduled with neutral venue.

- In Men's Novice Singles 2017 Ref 506, CLBC complained HKYDT informed opponent player the match venue within a very unreasonable time. After studying the case, Panel found that HKYDT met the requirement. No ruling is applied.

- In Women Novice Singles 2017, HKYDT requested to postpone SF because HKYDT were participated in Malaysia's event. Panel rejected it as according to bye law 6.9a.

Indoor Singles

- In Men's Indoor Singles 2017 Ref 199 CLBC vs STSA, the game could not be finished within 2-hour booking time and failed to agree a new date. After studying the case, Panel confirmed the match should be awarded to STSA. Please be reminded home side shall provide marker according to by law 1.2a and 6.8a.

- In Women's Indoor Singles 2017 Ref 220, both side could not arrange a date and time and sought for panel's decision. After studying the case, Panel instructed the date and time to finish it.

Men's National Fours

- In Men's National Fours 2017 Ref 202, KCC used a substitute without informing HKLBA. Therefore, the game was forfeited to CSD.
